**7.01** The planning applications were agreed and are attached at the end of the minutes.

## **8. 00 Amenities**

**8.01** Discounted fees for non profit making events at the recreation ground – The Clerk had been approached by the Commoners Defence charity to use the recreation ground in conjunction with the Hall, with no use of electricity or parking required. The Clerk asked for the hire fee to be reviewed. Cllr Channel thought that support should be given to Commoners and suggested that we charged a £50.00 fee which would be refunded if there was no expense to the Council – This was agreed by all – Resolved.

**9.00** Ditches and drainage update- Chairman Wild mentioned Cllr Grainger’s map distribution and it was felt that letters should be sent out by Highways to action problem areas, Cllr Bolton wanted the return of the highways log. Clerk will action when problems are reported.

**9.01** Consideration of lengthsman scheme – It was decided to use a log system to monitor reports to highways and the clerk will find out how the lengthsman scheme is working with other councils - action Clerk and Cllrs

**10.0** Conclusion of speed trial request at Pilley High Street – It was resolved to request the trial and monitor the speed at intervals to see if it works – Clerk to action

**11.0** To receive information from Councillors regarding matters from external meetings - The clerk mentioned the wiggle cycle event in the absence of Cllr Wooldridge, as he had been approached by two residents who had experienced

rude behaviour from cyclists in Norley Wood. Chairman Wild on the other hand had a positive experience and Cllr Puttick rode with them for a short while and found nothing negative to report back.

Cllr Channel went to the Verderers meeting and had a good insight into how they spend their money.

Chairman Wild informed the Council of the Hood Service taking place on the 19<sup>th</sup> May at 11.00am at St Johns Church. Cllr Channel planted some Thorn bushes at Perkins Piece
