# **BOLDRE PARISH COUNCIL**

Minutes of the Parish Council meeting held on Monday 13<sup>th</sup> October 2014 at 6.30 pm in the Boldre War Memorial Hall.

**Guest Speaker: James Brown "Our Past, Our Future"** – James gave an interesting overview into the project which is broken down into three parts: Landscape Partnership scheme working with Council's and other groups to share and input into the scheme. Developing Forest skills including apprentice rangers, building skills project, training for landowners and commoners and thirdly Discovering Forest Heritage including wild play areas. There will be a drop in session for further information open to all at Lyndhurst Community Centre on the 10<sup>th</sup> December.

The Chairman invited Mrs Langfelder to give an update on Speed Watch – There are 4 areas that share the speed indicator device and although there is a shortage of volunteers at present we have 6 new volunteers waiting to be trained by the police. Records show that the number of speeding vehicles has declined and the volunteers feel they have made a contributed to this. Letters have been sent out to offenders and three number plates are re offenders.

Members of speed watch pointed out that the roads within the parish are not just routes to get from A to B, cyclists, horse riders, walkers and children use these country roads and want drives to be considerate to other road users. One member suggested that there should be a metre of white lining for pedestrians to use where possible to feel safer, and another member mentioned the erosion of triangles within the village and that an adoption scheme should be looked at.

The Clerk read out a letter from Catherine Chatters who is seeking funding to continue controlling the spread of Himalayan Balsam at the Shallows and members thanked her and the team of volunteers for their continuing support.

The Clerk attended the New Forest Association of Council members meeting and will email the minutes out to members.

A discussion was had around awareness of ditches and drains and it was Cllr Bolton suggested that leaflets be delivered to every house hold in he parish and Landowners with a note from Boldre Parish Council starting with priority areas and that members should walk the parish to see where the priorities are. A question was asked by Cllr Wooldridge "when does a ditch filled in no longer be classed as a ditch?" – clerk to find out. It was decided a sub committee should be formed – action All. Some maps were given back to the clerk to mark up and some pages needed to be allocated - action Clerk

**10.00** Council Decision on the speed indicator device shared with Beaulieu and E.Boldre – Cllr Wise gave an update on the situation following a meeting with Cllr Vickers and said that the ownership is shared between the three parishes so we would need to wait for the outcome with Beaulieu and E.Boldre
