7.1Foot path monitoring and working party, action on footpath SS of B3054 and if works are required at the Shallows. - It was agreed that planning will allocate footpaths and have suggestions put forward at the next meeting With regards to further works at the Shallows a ditch could be dug out on the other side of the hedge but the alternative solution would be to coppice the trees and remove the tress from the ditch and also to look at the ditch on the other side. Action- clerk to contact Tree officer at National park and Cllr Channell to meet the officer at the Shallows.

Footpath SS of B3054 – It would be good to have this path would be good cleared so that parishioners can use it rather than the road – the foot bridge is almost non-existent – action – Cllr Channell to speak with land owner and clerk to see who owns it and look into getting it cleared.

8.00 Amenities – Information only – The football team had a good match – contract to be signed with the football team Thank you to Cllr Tanner for the work on the bench and Cllr Goodall commented on the good line marking done by Mr Jenkins our (groundsman)
