The applicant spoke briefly about the existing use of premises for antiques and modern furniture restoration and the application for a Certificate of Lawful development.

New NFDC Housing

Javid Ditta and Tim Davis outlined the need within the NFDC area for some 600 new homes. They are seeking sites suitable for section 106 Affordable Housing, and will compete for land with Housing Associations and Developers. The New Forest NPA remains the Planning Authority. Protection against the 'right to buy' can be included in NFDC developments, who hope to work with Parish Councils. Javid and Tim will investigate any land they own in Boldre such as garage sites that might be developed. Existing sites could be re-developed to increase density of housing. A survey of needs in the Parish was mentioned. There are some long term unoccupied properties that might also offer potential sites.
