The parish councils would pay the difference between the cost of the service and the fees collected (including those with bus passes). The majority of EBPC users would be happy with a service leaving at roughly 10am and returning at 2pm. The Council have heard with concern the proposed warding patterns being proposed as the Local Government Boundary Commission for England (LGBCE) works to review electoral boundaries and reduce the number of NFDC Councillors to from 60 to 49. The proposed split results appear to ignore the second and third criteria mentioned above for BPC.  Different areas of Boldre Parish would be served by separate NFDC councillors. Current lines which signify the Boldre and South Baddesley wards would also change. The proposals split Norley Wood, Portmore and South Baddesley away from Boldre and combine them with Lymington to achieve "Electoral Equality".  Boldre Parish Council feels that this will be to the detriment of BPC as the NFDC focus will tend to be on urban needs. The proposals also split the Boldre community. BPC will be raising these concerns as part of the consultation process.
