### **Meeting minutes**

This meeting was held in person with the above Councillors present. Other Councillors attended using Zoom technology but were not permitted to speak or vote on any items due to current legislation.

At the start of the meeting, it was agreed that the agenda would be shortened from that published. This was due to the rising rate of Covid cases and the subsequent conditions under which the meeting was required to take place.

In addition, several residents and visitors from East Boldre parish attended on Zoom to discuss the proposed purchase of speed indication equipment.

### NPA application 21/00983 - Butlers, Norley Wood

The applicant gave the meeting an overview of the planned change for a new garage & store. A previous extension for a garage/annex was made and approved over 10 years ago. No Parish Briefing Notes had again been received from the NPA prior to the BPC Planning Sub-Group discussing this application earlier in December.

The Chair of the Boldre Speedwatch Group (BSG) summarised the history and wish for newer technology to be (potentially) shared between Boldre and East Boldre Speedwatch groups.					
	BSG currently have the use of a seven-year-old SID with three other groups, not including East Boldre. This is relatively cumbersome for volunteers to set-up and transport to site. Some BSG volunteers have left the Speedwatch group because of the difficulties using this equipment. Three volunteers are needed at a location.  Only six locations are approved in Boldre Parish but further sites in Portmore, Norley Wood and				
	Boldre are being requested for approval from Hampshire Constabulary. Police attendance during SID use would be welcomed.				
	A new lighter device with two tripods and an eight-inch display unit, battery pack & charger would cost £1172 + VAT. £940 has been raised leaving a shortfall of £232. The VAT element of any purchase would be refunded if bought by a Parish Council.				
	The unit would be stored at a police station. The asset is insured by the police when in use. BPC established that volunteers are insured to use the device under the Council's insurance in 2019.  EBPC will discuss potential funding of £116 at their meeting on 9 <sup>th</sup> November 2021.				
	BPC approved funding of £116 (proposed by Cllr Moore, seconded by Cllr Slattery – four councillors were in favour with one abstention) and will issue a Grant application form to BSG for £116.

Making payments, including salary payments, for anything already agreed by the council by resolution and in line with the limits set by financial regulations.  Monthly review of payments and bank reconciliation with the Finance sub-group.  Arrange for the emergency repair of any council owned assets in consultation with the appropriate sub-group leader.  Planning - Responding to planning applications having first consulted with the Planning sub-group leader.  Planning sub-group to review items in the first week of the month Recommendations to be issued to Councillors by the Clerk.  Councillors have by the end of the 2nd Monday of the month to respond/comment. If a response is not made, it will be assumed to be an abstention.  Ad-hoc zoom call to be held for items where there are more than 2 objections (including splits within the planning group) to a given recommendation.
