Freedom of Information Policy

- 1. This policy has been prepared by Boldre Parish Council and commits the council to make information available to the public as shown in the table below. No information will be released where it discloses personal information which would breach the Data Protection Act.
- 2. Requests for information must be in writing to current parish clerk (this includes email) with full description, showing the name and address of the requestor. (See page 8 for details)
- 3. Boldre Parish Council will acknowledge the request within three working days together with a scale of appropriate charges and then reply with whether it holds the information and, if so, the information will be communicated to the requestor unless the work will take more than 18 hours to complete. In this case Boldre Parish Council is entitled to refuse to provide such information. A reply, together with any relevant information will be supplied to the requestor within 20 days. Where Boldre Parish Council has more than 17 requests for the same or similar information, the information will be aggregated.
- 4. If Boldre Parish Council does not comply with a request within the statutory deadline the requestor can appeal to the Chairman of the parish council. If the Requestor is not satisfied with this, they can appeal to the Information Commissioners Office:
